SECTION 109 OF THE LOCAL GOVERNMENT ACT 1972

ORDER

TO CONFER ON STUSTON PARISH MEETING CERTAIN FUNCTIONS OF  
A PARISH COUNCIL

RECITALS

- (1) The Parish of Stuston ("the Parish") is situated within the area of Mid Suffolk District Council ("the District Council")
- (2) There is no separate Parish Council for the Parish
- (3) In or about April 2016 the Parish Meeting for the Parish resolved that an application should be made to the District Council for an Order conferring on the Parish Meeting certain functions of a Parish Council as set out within the Parish Meetings' letter of 25<sup>th</sup> April 2016 addressed to the District Council
- (4) On the 22<sup>nd</sup> day of September 2016 the District Council resolved to exercise their statutory powers under Section 109 of the Local Government Act 1972 to make the required Order

**NOW THEREFORE** the District Council in exercise of their powers under Section 109 and Section 137 of the Local Government Act 1972 and all other enabling powers **HEREBY** makes the following Order:-

**1. Powers Conferred on a Parish Meeting**

The powers of a Parish Council set out in the Schedule below shall be exercisable by the Parish Meeting of Stuston from the date of operation of this Order

**2. Citation**

This Order may be cited as the Stuston Parish Meeting Order 2016.

**3. Date of Operation**

This Order is dated the 7<sup>th</sup> day of October 2016 and shall come into operation on the said date

**SCHEDULE**

**POWERS CONFERRED ON THE STUSTON PARISH MEETING**

Power to provide and maintain bus shelters under **Section 4 of the Local Government (Miscellaneous Powers) Act 1953**

Power to spend money on crime detection and prevention measures under **Section 31 of the Local Government and Rating Act 1997**

Power to drain and maintain ponds and ditches to prevent harm to public health under **Section 260 of the Public Health Act 1936**

Power to issue fixed penalty notices for litter and offences under the dog control orders under **Sections 58 to 67 of the Clean Neighbourhoods and Environment Act 2005**

Power to provide certain traffic signs and other notices under **Section 72 of the Road Traffic Regulation Act 1984**

Power to provide litter bins under **Sections 5 and 6 of the Litter Act 1983**

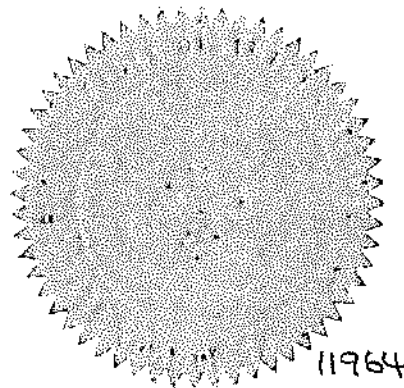
Power to deal with offensive ditches under **Section 260 of the Public Health Act 1936**

Power to provide recreational facilities under **Section 19 of the Local Government (Miscellaneous Provisions) Act 1976**

Right to be notified of planning applications within the Parish under  
Sections 62C and 252 of the Town and Country Planning Act 1990

Power to contribute financially to traffic calming schemes under Section  
274A of the Highways Act 1980
